### **Voter Suppression Defined**

**Voter suppression**: "Any legal or extralegal measure or strategy whose purpose of practical effect is to reduce voting, or registering to vote, by members of a targeted racial group, political party, or religious community." *Encyclopedia Britannica* 

### 18 U.S. Code § 594 - Intimidation of voters

Whoever intimidates, threatens, coerces, or attempts to intimidate, threaten, or coerce, any other person for the purpose of interfering with the right of such other person to vote or to vote as he may choose, or of causing such other person to vote for, or not to vote for, any candidate for the office of President, Vice President, Presidential elector, Member of the Senate, Member of the House of Representatives, Delegate from the District of Columbia, or Resident Commissioner, at any election held solely or in part for the purpose of electing such candidate, shall be fined under this title or imprisoned not more than one year, or both.

### **Voter Turnout Increased in 2022**

- Expanded safe and secure access to voting
- Additional resources given to counties with monetary needs
- Expanded vote by mail
- Increased ballot to drop boxes
- These resulted in increased voter turn out of
- BIPOC (Black, Indigenous, and People of color)
- Low-income people
- Students
- Others who were previously had difficulty accessing the ability to vote.

# **Examples of Voter Suppression**

- Voter roll purges
- Limiting access to voter registration
- Eliminating third party voter registration
- Strict voter ID laws and requiring addresses
- Limiting dates and times for early voting
- Limiting access to vote by mail
- Limiting the number of drop boxes for vote by mail
- Limiting Sunday voting


- Closed precincts
- Changing the location of precincts
- Too few ballots and poll workers purposely at precincts
- Exact match of signatures
- Broken voting machines
- Running out of ballots
- Opening polls late to cause long voting lines
- Making it illegal to provide food/water to those waiting in long lines

### **Voter Suppression: A Personal Narrative**

When Theresa Burroughs (1929-2019) came of voting age, she was ready to cast her ballot, but she had a long fight ahead of her. During the Jim Crow era, the board of registrars at Alabama's Hale County Courthouse prevented African Americans from registering to vote. Undeterred, Theresa remembers venturing to the courthouse on the first and third Monday of each month, in pursuit of her right to vote.

# **Gerrymandering Steps Into the Limelight**

### **Gerrymandering:**

When a political district map is redrawn to favor one party in elections, many times to favor white voters.

- Alabama
- Kinds of Gerrymandering
  - Political
  - Prison
  - Age
  - Racial

# Examples of how gerrymandering affects people other than in just one election

- A state led legislature refuses to expand Medicaid to help lower income and people of color
- The Flint Water crisis
- States banning transgender bathrooms
- Right to work laws enacted
- Limiting women's access to healthcare and abortion
- Refusal to enact stricter gun laws
- It impacts school board elections, city, county, and other local governing bodies elections and state legislatures
- It's not just impacting a congressional map or a presidential election.



Use one of these 3 ways to vote!

**Early voting - in your Election Office:** Feb. 2, 2024 – March 19, 2024

**Vote by Mail -** Submit application beginning December 20, 2023 Ballots mailed to applicants beginning Feb.8, 2024 Mail ballot must be <u>received</u> in the local election office by March 14

Last day online voter registration: March 3

Vote on Primary Election Day March 19 – March 19, 2024 6:00 AM – 7:00 PM Vote only at your assigned polling place.



Stacey Abrams: Educators' Call to Action "The consequences of silence have not been outweighed by the consequences of action," Abrams said.
